# **Proof of Consent**

## 1. Introduction

Our website, <a href="https://play.hymnswithoutwords.com">https://play.hymnswithoutwords.com</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ## 2. What are cookies?
